The Hicksville Public Schools is anticipating the curriculum projects listed below. These projects will be completed between July 7, 2016 and July 13, 2016.

Staff members wishing to be considered as curriculum writers should indicate their interest and qualifications in a letter to Rosemarie Coletti, Assistant Superintendent for Personnel, Administration Building, no later than Friday, July 1, 2016.

Compensation will be in accordance with the Board of Education-HCT Agreement and will include the responsibility for proofreading the final typed document and presenting it to the Board of Education.

## I. Middle School Advisory

This document will include a calendar of events and activities by theme by month to provide teachers with a variety of options to use when meeting with their advisory students. This curriculum will be written between July 7 and July 13, 2016. Ten hours are being requested for each of three teachers.

### II. Special Topics in the Humanities

This document will include curriculum mapping of five to six units defining protocols for research aligned to the State Education Department's Researching to Deepen *Understanding* document. Assessment procedures, scoring rubrics and supporting resources will also be included in this project. The curriculum will be written between July 7 and July 13, 2016. Twenty hours are being requested for each of three teachers.

### III. English 11 Regents ENL

This proposal includes identification of three major works to be read in co-taught sections, writing unit plans, identify informational texts with differentiation by reading level, creation of chapter by chapter vocabulary lists, articulation of assessments with corresponding scoring rubrics and differentiated supporting resources. The curriculum will be written between July 7 and July 13, 2016. Twenty hours are being requested for each of three teachers.
